Article 1

Article 3
TIME AGREEMENT

1. This cooperation agreement is valid for 5 (five) years.

Article 4
FINANCING

The financing that arises in the implementation of this collaborative activity is discussed by both parties and is arranged according to a mutual agreement.

Article 5

2. All disputes that may arise as a result of this agreement, will be resolved through kinship based deliberation to reach consensus.
